- Although the 10 key indicators don't capture the full range of conditions shaping children's lives, these indicators possess three important attributes:
 - 1. They reflect a wide range of factors affecting the well-being of children, such as health, adequacy of income and educational attainment.
 - 2. They reflect experiences across a range of developmental stages-from birth through early adulthood.
 - 3. They permit legitimate comparisons because they are consistent across states and over time.
- The 10 key indicators of child well-being used in the report are all derived from federal government statistical agencies and reflect the best available state-level data for tracking yearly changes in each indicator.
- Small differences, within a state over time or between states, may simply reflect random fluctuations, rather than real changes in the well-being of children.
- In 2009, some dimensions of well-being improved, some worsened, and some showed little change. However, the overriding picture that these 10 indicators present is one of little change since 2000.
- The portrait of change in child well-being since 2000 stands in stark contrast to the period just prior to 2000. Between 1996 and 2000, 8 of the 10 key indicators used in KIDS COUNT improved. The improvement was experienced by every major racial group and in nearly all of the states.
- Between 1994 and 2000, the child poverty rate fell by 30%. Since 2000, however, improvements have stalled and the child poverty rate has increased by 6%.

Definitions

- Percent of Low-Birthweight Babies: The percentage of live babies weighing less than 2,500 grams (5.5 lbs.) at birth. Source: US Center for Disease Control and Prevention, National Center for Health Statistics
- Infant Mortality Rate: The number of deaths occurring to infants under 1 year of age per 1,000 live births. Source: US Center for Disease Control and Prevention, National Center for Health Statistics
- Child Death Rate: The number of deaths to children between ages 1-14, from all causes, per 100,000 children in this age range. Source: US Center for Disease Control and Prevention, National Center for Health Statistics
- **Teen Death Rate:** The number of deaths from all causes to teens between the ages of 15-19, per 100,000 teens in this age group. *Source: Death Statistics: US Center for Disease Control and Prevention*
- **Teen Birth Rate:** The number of births to teenagers between ages 15-19 per 1,000 females in this age group. *Source: US Center for Disease Control and Prevention, National Center for Health Statistics*
- **Percent of Teens Who are High-School Dropouts**: The percentage of teenagers between ages 16-19 who are not enrolled in school and are not high school graduates. Those who have a GED or equivalent are included as high school graduates in this measure. *Source: US Census Bureau, American Community Survey*
- **Percent of Teens Not Attending School and Not Working**: The percentage of teenagers between ages 16-19 who are not enrolled in school (full or part-time) and not employed (full or part-time). *Source: US Census Bureau, American Community Survey*
- Percent of Children Living in Families Where No Parent Has Full-Time, Year-Round Employment: The share of all children under age 18 living in families where no parent has regular, full-time employment. Source: US Census Bureau, American Community Survey
- **Percent of Children In Poverty**: The percentage of children under age 18 who live in families with incomes below 100% of the federal poverty level (\$21,027 for a family of two adults and two children in 2007). *Source: US Census Bureau, American Community Survey*
- Percent of Children In Single Parent Families: The percentage of children under age 18 who live
 with their own single parent, either in a family or subfamily. In this definition, single-parent
 families may include cohabiting couples and do not include children living with married
 stepparents. Source: US Census Bureau, American Community Survey
