### SECA By-laws Amended at the Annual Business Meeting

The annual business meeting of the Southern Early Childhood Association was held on Saturday, March 31, 2007 at the annual conference in Jacksonville, Florida. Two changes to the SECA by-laws were adopted at that meeting.

1. **All SECA members are now on a standard membership year.** The membership begins on the date that the membership is posted by the SECA office and is valid for one year from that date. (For example, if the membership is posted in the SECA office on April 1, 2007, the membership will expire on April 1, 2008. Your SECA expiration date may vary slightly from your state expiration date due to delays in processing and receipt of information in the SECA office.)
2. **If a vacancy should occur in the office of President, the Immediate Past President or President-Elect will automatically assume the office of President.** Previously the Vice-President (an appointed position) would assume the office. This change ensures that a person elected by the membership will always fill the role as President of the organization.

## Annual SECA Awards Support Our Affiliates and Chapters Throughout the South

At the 2007 Annual Conference, a Marian B. Hamilton Award was presented to the Northern Virginia Association for the Education of Young Children. This award (\$250) is presented each year to three states in the SECA region to support state and local affiliate projects. The Virginia Association for Early Childhood Education (our state affiliate) selected a project of the Northern Virginia Association as their state's award recipient for 2007.

The Northern Virginia Association for the Education of Young Children's (NVAEYC) Scholarship Program provides financial support to child care professionals who are pursuing an academic degree or a Child Development Associate credential and to child care programs that are implementing training programs and professional development for staff.

NVAEYC was fortunate during 2006-2007 to be able to expand its annual scholarship program by partnering with the Fairfax County School Readiness Collaborative (SRC). The SRC is funded by one of three "Investing in Virginia's Children" grants awarded in the state. Recipients of this year's scholarships represented a diverse group of professionals—family child care providers, teaching staff at child care centers and preschools, an instructional assistant with the public schools and a center director.

The other recipients of the 2007 Marian B. Hamilton Awards were the West Virginia Association for Young Children to support their Ann B. Nutt Memorial Scholarship Fund and the Student Chapter of Coastal Bend College, the recipient nominated by the Texas Association for the Education of Young Children.

SECA is pleased to be able to support such significant projects at the local level and look forward to providing those awards in 2008 to projects in the states of Alabama, Arkansas and Florida.

The Southern Early Childhood Association serves the needs of professionals, paraprofessionals, parents and others in early childhood education and care. This includes professionals who work with children ages birth-8 years and SECA is seeking a balance of presentations, including **Infant/Toddler, Preschool, Primary and School-age**, for each conference. The planning committee for the conference seeks sessions on innovative practical experiences, programs and applied research in the following areas.

- Child Growth and Development
- Classroom Management and Discipline
- Curriculum Development & Implementation
- Assessment and Evaluation
- Leadership and Management
- Professional Growth and Teacher Preparation
- Community Involvement
- Public Policy
- Family Partnerships
- Diversity
- Applied Research
- Other (If you feel that your topic does not fit under one of the listed topics, you may use the "other" category, and the proposal review committee will determine the appropriateness of your topic for the SECA audience.)

You may propose workshop and interest group presentations that focus on the topics outlined above. **Proposed sessions may be 1 1/2 hours or 1 hour in length.** If your proposed session is accepted and is proposed for 1 1/2 hours, you may be asked to reduce the session to 1 hour in length in order to accommodate scheduling.

SECA will not accept proposals based on the same title or content for more than 2 years. Previously submitted and accepted proposals will receive review after all other proposals have been accepted or rejected.

#### Use of Audiovisual Equipment

**SECA does not provide AV equipment for interest sessions.** Proposals that are dependent upon AV equipment may be rejected unless the presenter states his/her intent to provide AV equipment. Presenters may rent AV equipment through the approved conference vendor or bring their own equipment on-site.

**SECA does not have funds available to compensate interest session presenters.** All presenters must register for the conference. The **Lead Presenter** (as identified in the proposal) is provided complimentary registration for the core conference. (Friday & Saturday)

**Proposals must be postmarked by August 1, 2007.** Notification of acceptance will be made by October 1, 2007.

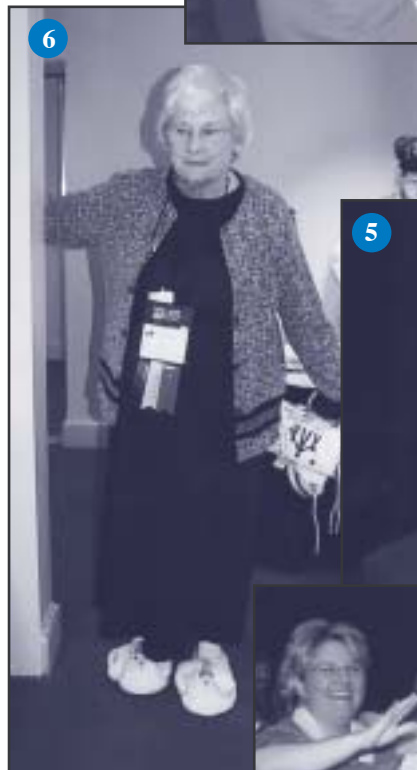
#### Proposals Should Include:

1. **Name, address, telephone number, e-mail address and professional title of individual making proposal.** If there are multiple presenters, this information is required for each presenter.
2. **Vita for all presenters.** (This may be a brief vita of 1-2 pages.) SECA does not maintain archives of vitas from previous presenters, so your vita must accompany the proposal each year. **(There are no exceptions to this requirement. SECA must have presenter vitas in order to award CEU credit for the conference.)**
3. **Title of presentation** that clearly and concisely describes its content. SECA reserves the right to edit titles if the presentation is accepted.
4. **Workshop classification** from topics listed above.
5. **Presentation Language (English or Spanish or both)**  
Spanish language presentations are encouraged.
6. **Description of presentation including:**
  - a. Goals/objectives for presentation
  - b. Synopsis of content (including a presentation outline)
  - c. Type of presentation techniques to be used
7. **Abstract** appropriate for use in the conference program *(This abstract should not exceed two sentences.)*
8. **Brief narrative** (150 words or less) outlining the presenter's qualifications to do this presentation
9. **List of presentations** during the last 3 years, including title of presentation, audience, site of presentation (conference, training event, etc.) and date.

## New Preschool Resources

The National Center for Children in Poverty (NCCP) has a new report entitled, *Effective Preschool Curricula and Teaching Strategies: Pathways to Early School Success*. Included is information from research and practice about curricular and teacher support strategies that are critical to reducing the achievement gap for young, low-income children. The full text and summary of the report are

available at [http://www.nccp.org/pub\\_pes06b.html](http://www.nccp.org/pub_pes06b.html). The National Institute for Early Education Research (NIEER) has produced “*Is More Better?*” *The Effects of Full-Day vs Half-Day Preschool on Early School Achievement*. Results from a randomized trial that compared children in half-day and full-day programs show that children attending full-day programs did better on mathematics and literacy tests and that the achievement gains continued until at least the end of first grade. ## Education Week Develops a “Chances-for-Success Index” .....

The “Chances-for-Success Index” was developed to assist in predicting an individual’s opportunity to achieve a successful life in their state. The index combines information from 13 individual indicators which include family income, parent education, preschool enrollment and others. Here’s how the Southern states fared:

## What’s Happening in the SECA States .....

### Arkansas

The state of Arkansas just concluded its biennial legislative session and early childhood education was a winner. The state allocated an additional \$40 million per year to pre-K, bringing the total funding allocated to support pre-K to over \$100 million dollars. Arkansas is moving toward a voluntary, universal pre-K program and has a new Governor, Mike Beebe, who is dedicated to supporting that effort.

### Florida

Governor Crist has taken a leadership role in supporting several children’s issues during the Florida legislative session. The Governor spoke at a press event in favor of degreed teachers in Florida’s pre-K classrooms. An opinion editorial, signed by six of Florida’s former governors and Rhea Chiles, the wife of the late Lawton Chiles, helped to bolster the press event and keep the focus on children’s issues. ### Louisiana

In her executive budget and agenda for the current legislative session, Governor Kathleen Blanco asked for \$611 million for education initiatives to fund teacher pay raises, expand the pre-K system and fund a high school redesign plan. This proposal is being considered in the current legislative session.

### South Carolina

Fifteen months ago, a circuit judge ruled that South Carolina failed to provide its youngest residents with sufficient early childhood education programs. This decision came as a part of a school equity lawsuit, filed by eight rural school districts against the state. In response, the South Carolina General Assembly allocated \$23.5 million to a pre-K pilot program in many low-income districts. Critics say that the pilot program doesn’t begin to address the judge’s ruling and discussions are on-going about going back to court to ensure that the program goes statewide. ### Texas

Texas Appleseed, a public interest law center, has published a report analyzing the use of alternative schools and the effectiveness of zero-tolerance policies in Texas school districts. The report found that more than 100,000 students per year are sent to Disciplinary Alternative Education Programs. Of those students, nearly 600 were pre-kindergarten/kindergarten students and more than 3,000 were first-graders. Texas lawmakers are considering changes to the state discipline system.

### Virginia

The Virginia General Assembly finished its work on April 4, 2007. During that legislative session, lawmakers approved a bill that would require children 8-years-old and younger to be in booster seats while riding in a vehicle, boosted teacher pay by 3 percent, expanded publicly funded preschool (although not as much as Governor Kaine had proposed) and added money to enhance the state’s reading program for struggling readers. ### West Virginia

West Virginia was recently recognized as one of only six states in the country to make pre-kindergarten education available by law to all children. The NIEER report ranked West Virginia sixth in the nation in terms of accessibility. Two benchmarks, teacher degree requirements and assistant teacher degree requirements, are still to be achieved.
