After the Hurricanes of 2005

In the aftermath of the 2005 hurricane season, the early childhood community banded together to support their colleagues along the Gulf Coast who faced devastation and loss. SECA developed several ways for people to help:

- Providing information about where to send books and supplies.
- Matching supporters with programs that had been affected.
- Collecting financial contributions to be used to support re-development of centers and homes.

The donated books and supplies and "adopt a program" were immediate steps that were taken in 2005 and early 2006. SECA is now moving forward to utilize the donated funds to assist in the rebuilding effort.

The funds donated for Hurricane Relief are being used in the following ways:

- A check was sent to the Early Childhood Association of Florida in early 2006 to assist them in providing grants to the providers in Florida who experienced damage from the hurricanes. ECA of Florida provided grants of \$250 to providers who were members of the Association, and SECA enhanced the funds they had available.
- SECA will purchase math kits from Lakeshore Learning to distribute to the Mississippi Gulf Coast providers who were victims of the storms. These kits will be distributed in a training session scheduled for September 23, 2006 at Gulf Coast Community College. The session is co-sponsored by the Mississippi Early Childhood Association.



Lakeshore Learning has developed these kits especially for SECA and the Hurricane Relief Effort. SECA will donate its book, *Mathematics for Young Children*, for the kits that will go to Mississippi.

As recognition that this effort will continue far longer than one hurricane season, Lakeshore Learning has agreed to make these kits available for sale to its customers and will donate a portion of the proceeds from the sale of the kits to the SECA Disaster Relief Fund. Everyone who purchases a SECA Pre-School Math Kit from Lakeshore Learning will be making a contribution to the well-being of their colleagues in these devastated areas.

Our thanks go to Lakeshore Learning for their sense of corporate responsibility and their desire to support and improve the quality of life for the South's children and families.

The Award will be presented at the 2007 Annual Conference in Jacksonville, Florida.

Program Directors: Education, Salary and Benefits

The *2005 Directors' Salary Survey* was distributed between January and June 2005 by the McCormick Tribune Center for Early Childhood Leadership and Child Care Information Exchange. The survey was designed to gather information about directors' salaries in relationship to their professional qualifications, the program type of their center and their sources of funding.

Some of the findings from those directors who were surveyed .

- Seventy-six percent (76%) of the directors have a minimum of a BA degree. Thirty-two percent (32%) of those have gone on to a graduate degree.
- One-third of the directors (32%) have less than 24 hours in child development or early childhood education.
- Almost one-half (47%) of the directors had less than 3 hours in program management.
- The mean annual salary for an administrator of a single site program was \$42,765.
- The salary differentials were significant based upon the type of program they managed. Directors of for-profit programs were paid less than directors of college or university programs.
- There is a positive correlation between a director's education and salary.
- Less than 2/3 of directors of for-profit and private non-profit programs receive health insurance.
- Only thirty-four percent (34%) of directors of for-profit or private non-profit programs received retirement benefits.

Early Care and Education Participation Among Immigrant Families

High quality early childhood education is universally recognized as one significant strategy of assisting at-risk children and preventing school failure. Children of immigrant families are particularly benefited by participating in an early childhood program but less likely to participate in such programs.

The Center for Law and Social Policy published *Reaching All Children? Understanding Early Care and Education Participation Among Immigrant Families* in January 2006. The report gives some statistics that have enormous implications for early childhood education.

One out of every five children in the United States lives in a family with at least one foreign-born parent. According to the 2000 US Census, children in immigrant families are the fastest growing segment of the child population in the United States. Ninety-three percent (93%) of children of immigrants under the age of six are US citizens and will live in the United States permanently.

Children of immigrants are less likely to participate in every type of non-parental care and early education than children of US born citizens.

- The majority of children of immigrants are in parental care or do not have a regular care arrangement.
- Relative care is the most common form of child care.
- Center based care is infrequent.
- Census data suggests that children of immigrants are under-enrolled in preschool.

What factors influence participation of children of immigrants in preschool?

Children of immigrants are:

- More likely to be living in low-income households.
- Have parents with less formal education.
- More likely to live with both parents but less likely to have both parents working.
- Impacted by the nature of immigrant employment.

Trike-A-Thon

The St. Jude *Trike-A-Thon* is a free, one-week curriculum that teaches children riding-toy safety with a series of interactive stories and lessons featuring a character named Bikewell

Bear. Teachers receive a professionally illustrated storybook designed to help students learn a different safety lesson each day.

At the end of the *Trike-A-Thon* week, students bring their trike or riding-toy to school and practice

all of the rules they have learned. Parents turn in donations collected from friends, family and co-workers. Children learn riding toy safety, help St. Jude, and earn fun prizes for participating.

Every *Trike-A-Thon* coordinator kit includes the storybook, *Bikewell and Pedals' Big Trike Adventure*, which teaches the four major safety rules through daily lessons:

- Always wear your helmet.
- Don't ride in the street.
- Always be careful around driveways.
- Always watch where you are going.

Every student that participates in *Trike-A-Thon* will receive a Bikewell Bear license. St. Jude also offers fundraising awards for students and schools.

Math-A-Thon

Math-A-Thon is a supplemental math education program for grades K-9 that also serves as a fundraiser for St. Jude

Protecting Children from a Flu Pandemic

If you are watching the news, you've been seeing news bulletins about a possible "bird flu" pandemic that may be coming our way. Although it hasn't happened yet, many groups in the United States are planning to ensure that we're ready in case something of that seriousness and magnitude develops.

The Centers for Disease Control in Atlanta have developed a *Child Care and Preschool Pandemic Influenza Planning Checklist* that is available on their website at www.cdc.gov. Check under the School Planning button on the Pandemic Flu section.

The checklist contains check-offs about planning and coordination, student learning and program operations, infection control policies and actions and communications planning that includes a statement about family planning for an epidemic. These are all things that you can do **NOW** to be sure you're ready in case this ever becomes an issue.

Additionally, Glenda Bean, Executive Director of SECA, is a member of the CDC Child Care Planning Committee that is working to develop further resources for the child care community. We'll pass along information as it becomes available.

No one wants to envision that a flu pandemic might be coming but good planning is the best way to be prepared. Get the checklist today and make sure you're ready to act if it should be necessary.

What's Happening in the SECA States

Arkansas

The State of Arkansas is showing a record surplus of \$600 million from tax collections in 2006 and Governor Huckabee has expressed his desire to refund that surplus to taxpayers. Lawmakers are discussing whether the surplus might be more effectively utilized and expanding the ABC program (the state pre-K) has been mentioned. Future tax cuts to reduce the surplus are also being discussed.

Florida

When children start kindergarten in August, they will be tested with the Florida Kindergarten Readiness Screener, a new assessment in 2006. The Screener uses two components of the DIBELS assessment and parts of the Early Childhood Observation System developed by Harcourt Assessment, Inc.

Kentucky

Programs have been notified that early childhood accreditation provided by the Southern Association of Colleges and Schools will be accepted for the "Excellence" requirements for public schools and for licensed centers who are working through the Quality Rating System. NAEYC accreditation is also accepted.

Mississippi

The State Superintendent of Education, Dr. Hank M. Bounds provided an editorial in the *Daily Times Leader* that included strengthening pre-kindergarten programs as one strategy to promote education. He recommended that the state fund at least a pilot program if it could not fund a statewide program. Mississippi currently has no pre-K program.

The Early Childhood Institute at Mississippi State is sponsoring *Project Joy*, a training program to help providers understand the impact of childhood trauma and how to use play to support the social-emotional development of children.

Oklahoma

The Oklahoma State Department of Education has developed a pre-kindergarten language screening test for English Language Learners and bilingual students. The tool will be available for the 2006 school year.

South Carolina

South Carolina lawmakers dedicated \$23.6 million to creating 4-year-old programs in 2006. The money falls short of the Superintendent's request of \$100 million. The program will serve 8200 children from low-income families who currently don't have access to a pre-K program.

Tennessee

Governor Phil Bredesen announced the addition of \$20 million to the state's pre-K program for the 2006-2007 school year. 136 Tennessee school systems will receive state funding to add pre-K classrooms. Each new classroom is expected to cost about \$100,000.

Texas

San Antonio mayor, Phil Hardberger, convened a summit this summer to develop strategies to move the community forward. Early childhood education was recommended as one of three strategies.

Virginia

Governor Timothy Kaine convened a 23-member panel, called the Start Strong Pre-K Council, that will examine preschool services statewide and recommend ways to make early childhood education an option for all families.

West Virginia

Marshall University has received a \$300,000 grant to provide professional development and assistance to pre-school teachers. The program will be offered statewide.
